  - I. Please do feel free to schedule an appointment with our staff before arriving or set something up for another day. To allow for as little traffic foot print our office areas/nursing station/rehab area is **BY APPOINTMENT ONLY**.
  - J. Please note that our Ground Floor will not be accessible to visitors.
  - K. There is no lunch available to visitors or Vending Machine access at this time.
8. ALL VISITORS MUST INFORM SECURITY WHEN YOU ARE LEAVING FOR THE DAY.

## **Outbreak Testing Notice**

**Friday, December 17, 2021, 3:45pm**

An outbreak investigation has been initiated due to a new admission to Chapin Home who has subsequently tested positive for COVID-19. To swiftly detect, identify and/or rule out other cases, Chapin is adhering to CMS regulations and guidance for COVID-19 outbreak testing.
